

## PRIVACY POLICY

At Magnax , we value the privacy of our visitors. This privacy policy document outlines the types of personal information which are received and collected by Magnax and how it is used. This document explains:

- What personally identifiable information is collected from you, how it is used and with whom it may be shared.
- What choices are available to you regarding the use of your data.
- The security procedures in place to protect the misuse of your information.
- How you can correct any inaccuracies in the information.
- That by using our site, you consent to the terms of our privacy policy.

### Information, collection, use, and sharing

We collect information from you that you voluntarily give us via email, when you register on our site, subscribe to our newsletter, download our publications or other direct contact. Next to this we also collect information through cookies (see next paragraph). We are the sole owners of the information collected on this site and will not sell or rent this information to anyone. We will use your information to respond to you, to communicate with you, our customer, supplier, applicant or prospect, to deliver our services, to sell you a product or service, to send you a newsletter, to ask for your feedback, to keep you posted about events we organize and you might be interested in, to contact you for a job interview when you apply for a job. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.

### Cookies

We use "cookies" on this site. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance the experience on our site. Usage of a cookie is in no way linked to any personally identifiable information on our site.

You will be asked to either accept or decline our cookies when you enter or website for the first time. You can also disable cookies through your individual browser options. In principle, you can also access all the information on our web pages if you have disabled cookies. In case you do not accept cookies, this can lead to a limitation of functionality.
